BRU Fee Schedule

STVHCS Per Diem Charges will be that amount most closely approximating the cumulative sum of the following service charges:

- · <u>Nursing Services</u> provided at an average personnel expense of \$60 per hour of nurse labor starting from a minimum of \$30 for a 30 min patient visit.
- · <u>Dietary and Nutritional Counseling</u> provided at an average personnel expense of \$48 per hour of dietician labor starting from a minimum of \$24 for a 30 min patient visit.
- · Food, Snacks, and Meals provided at \$4/snack (food item from the BRU food service snack menu and a drink), \$8/regular meal (food from the main STVHCS kitchen daily menu and/or BRU food service prepared food that cannot be obtained from the main kitchen and a drink), \$16/special meal (specially prepared constant or timed diets cooked by BRU food service staff requiring standard recipes and maintenance of nutrition records and a drink), and \$20/complex meal (constant diets that require pre-preparation, weighing, maintaining nutrition records and funds for special food purchases and a drink).
- · Administrative expenses \$20 per patient day.
- · General Unit Operation expenses \$22 per hour.
