

Clinical Research Unit (CRU) & Coordinator Service Pool (CSP) FEE SCHEDULE

Fees are structured on a per hour, per diem, or per service basis and are based on the cost incurred by the CRU and CSP for providing the service, which includes personnel costs, overhead, supplies, equipment maintenance, and any administrative costs related to scheduling and billing.

Rates for **junior investigators** and **PI-initiated studies** will be determined on a case-by-case basis and is dependent on the budget available to complete the entire study. **CTSA KL2 Scholars** will receive a 50% discount off the NIH rate for all services.

Studies are charged only for services used and in the amounts used.

| CRU Study Initiation and Closure Fees (one-time fee) – Limited Services <i>Application of this rate will be determined on a case-by-case basis and is at the sole discretion of the CRU. If additional services are requested at a later date, the balance of the Initiation and Closure Fee (to total the amount equal to either the Industry or Non-Industry rate, as applicable) will be charged in conjunction with a new Letter of Agreement (LOA) adding those additional services.</i> | \$250 | \$250 |

| Cold Storage (Initial and annual) <i>Includes short-term storage of specimen and temperature monitoring. Charged until all specimen removed from cold storage equipment.</i> | \$50 | \$50 |
| Pharmacy Inventory/Storage fee (annual) <i>Includes storage of study materials (e.g., inventory, recordkeeping, temperature-monitoring). Charged monthly until IP and pharmacy records returned to study team.</i> | \$300 | \$200 |
| Staff Protocol Training (Additional Intensive) <i>Per hour, billed in 15-minute increments (rounded to the next highest increment), including travel time. Includes attendance at required sponsor training via on-line, phone, or in person, etc.</i> | \$50 | \$50 |
| Record Storage Fee <i>All data collected by CRU staff during research visits shall be the property of the PI, and the PI will be advised, upon CRU closure of a study (CRU services no longer required/requested), when records are available for pick-up. This fee will be charged at the beginning of each month after the expiration of 10 business after notice of availability for pick-up if the study team fails to retrieve the records from the CRU.</i> | \$50/month/ file box | \$50/month/ file box |
